Instructions:

Abstract format:

- One page abstract 8.5" x 11", with 1" margins all around, MS Word (11pt Calibri, and/or symbols). No pdf files.
- Center title, authors, and affiliation at the top.
- Leave one blank line between title and authors, and between authors and affiliations.
- Print title bold, all uppercase (except chemical symbols).
- Type the names of the authors (mixed case) and underline presenting author's name.
- Type author affiliations.
- Type e-mail address of the presenting author.
- Leave another blank line.
- Type abstract text, single-spaced, with one blank line between paragraphs. Graphs and images can be included, as long as the entire abstract fits on one page.

Please indicate at the bottom of the abstract if you prefer to give an oral presentation or a poster presentation.

Please also include "**HMAVS Fall 2015 Abstract**" in the subject line of your email.

The executive committee will select 6 abstracts for oral presentations. Each oral presentation is limited to 20 minutes (includes 15 minutes for presentation and 5 minutes for question and answer). Oral presentations not selected will be invited to participate in the poster session.
