# Approval of Dec. 19, 2012 Minutes

# Plans for Short Courses in Burlington June 10-11, 2013

## Involving our Vendors and Symposium Attendees

• **Peter S.** suggested and there was agreement that since we decided in Dec. not to hold a 2013 Symposium, Peter should write a letter to our regular vendors and symposium attendees, informing them of our decision and explaining that we are planning to organize a 2014 Symposium, but that in 2013 we are only hosting dinner meetings and short courses. The letter, which is planned to go out by Feb.11, will also inform them that we are attempting to reach out to AVS vendors and members in the southern part of New England to evaluate holding more activities in that area (e.g. the Hartford area) in the future.

#### **Discussion of New By-Law**

• **Peter S.** presented the board with the template to be used to draft new by-laws for the New England chapter. The initial draft was 5 pages, and the committee worked through the 1 and 2 pages. The remaining pages would be reviews by the board members on their own and their input would be forwarded to Peter by Feb.18. We would then send them to AVS national for review and finally we would like to have them approved in April, so that we can hold elections in the fall.

#### **Plans for 2013 Board Elections**

• It was agreed that after the by-laws have been approved by AVS National and have been voted on, we are planning to hold elections for the board sometime in Nov.

#### **Treasurer's Report**

• **Dick J.** reported that AVSNE currently has a bank balance of approx. \$6000.

- **Peter S.** reported being contacted by the Radisson in Nashua NH asking if we would consider using them as a venue for one of our events. Peter will respond to them that we do not have any event currently planned, but will keep them in mind for the future.
- Earl A. has made an offer to our committee to invite interested AVSNE members to participate in several workshops to be held at UMass Lowell . Jim W. agreed to solicit more information about the workshops and report back to our board.
